## PROCEDURE FOR OBTAINING BUSINESS PREMISE PERMIT

## **Guiding Laws & Regulation**

In pursuant of the provisions of Adamawa State Revenue Administration Law, No. 2020 First Schedule, Section 4, Item 23, Business Registration Permit, Page 82

All individuals and organizations seeking to obtain a Business Premise Permit in Adamawa State can apply through the following process;

STEP 1: Start your registration by obtaining the registration form at the Ministry of Commerce and Trade, Deputy Governor's Office, Opposite Mahmud Ribadu Square or any of the 21 Local Government Area commercial area offices.

#### STEP 2: Prepare all relevant documents.

To process your application for BPP the following documents are required:

- Corporate Affairs Commission (CAC) Registration Certificate (For small, medium and largefirms)
- ✤ A Certificate of Business Registration (for micro businesses)
- Tax Clearance Certificate (TCC) and Tax Identification Number [TIN] (for all formsof business).

## STEP 3: Pay applicable fees.

Pay the applicable fee as provided in the Schedule of fees can be found on Adamawa State Revenue Administration Law, No. 2020 First Schedule, Section 4, Item 23, Business Registration Permit, Page 82 and accessible via the link shared below.

\*\*Upon Submission of your application form, applicants will be provided a unique ApplicationReference Number and an acknowledgment letter that carries the file

number for the application

### STEP 5: Approval and issuance of Business Premises Permit (BPP)

Submitted applications for business premises permits will be processed **within 48 hours** and applicantswill be notified within the same timeline to collect BPP permits.
