1.0 OPENING PRAYER / COMMENCEMENT: The meeting commenced with opening prayer by Members at about 11.00 am.

<u>WELCOME REMARKS</u>: The Chairman welcomed all Members present and appreciated the attendance of all Stakeholders, despite the short notice. He also prayed for the success of the meeting and the SABER's Project in general.

- 3.0 <u>CONSIDERATION OF MINUTES OF THE 1<sup>ST</sup> MEETING</u>: The Minutes of 1<sup>st</sup> meeting was considered, thereafter, Mr. Jonathan Solomon moved motion for the adoption of the minutes and the motion was seconded by Auwal Bashir. Consequently, the minutes was adopted.
- 4.0 MATTERS ARISING FROM THE MINUTES OF THE 1<sup>ST</sup> BOARD MEETING: The following issues were considered as Matters Arising from the Minutes of 1<sup>st</sup> Board Meeting:
  - A. THE YEAR 2023 ADAMAWA SABER'S ACTION PLAN: The Adamawa SABER's Action Plan was reviewed, and it was shown that Action-Areas or Steps relating to Land administration, registration, certification, and automation has been implemented to certain extent. It was also shown that achievements in respect of Action-Area relating to Tax Processes were made. However, the meeting observed that, low achievement was recorded in terms of 'ease of doing businesses and or promotion of investment as was provided under the 2023 Action Plan.
  - **B.** The meeting resolved to put concerted efforts towards achieving the low identified areas, in the year 2024 milestones.

#### **DAY'S/NEW BUSINESS:**

5.0 THE YEAR 2024 ADAMAWA SABER'S ACTION PLAN: The templates for the year 2024 Action Plan were presented by the focal Person of SABER, Adamawa State Chapter in

Person of Dr. Bello Abubakar Song and the meeting has extensive discussed and agreed as follows:

- A. Seven Enabling Reform Areas were identified, namely:
  - Development of Institutional and Procedural Framework for Land management and (i) Administration
  - Development of Digital Enabled Land Administration Process with a view of (ii) achieving Land transfer title within 72 hours.
  - Improved regulatory framework for Fiber Optic Infrastructure (iii)
  - Improved Sustainable Large-Scale Investment (iv)
  - Establishment of Designation of Special Courts for handling Commercial and (v) business Dispute
  - Harmonizing and ease of State Tax Process (vi)
  - Transparency of Fees and Levies for Inter-state and intra-state trade. (vii)
- B. Inputs were made and agreed in terms of:
  - (1) How to achieve the Areas identified under paragraph 5a above,
  - (2) Objective were set,
  - (3) Relevant Stakeholders that will carry out the project, from the business-community and the MDAs were identified,
  - (4) Timelines were set/agreed, and
  - (5) Budget for implementation of the identified Areas were proposed and agreed by the attendees of the meeting.
- C. The meeting deliberated and selected a 'Five Man Committee' to impute the resolutions of the day's meeting into the provided templates and submit to the Adamawa SABER Office on Monday morning the 25th September 2023. The selected five Members were: Barr. Ibrahim B. Mustapha, Fidelis Jonnah Omeh, Sadiq Sagir Manchi, Auwal Bashir and Abubakar Rufai. The Committee was called upon to coopt all relevant Representative of MDAs which include the following: Ministry of Land & Survey, ADGIS, Board of Internal Revenue, etc.
- 0.6 CLOSING REMARKS BY THE CHAIRMAN: The Chairman on behalf of the SABER's Office and ADCCIMA, which is the hub of organized Private Sector in the State, appreciated

the contribution of all Stakeholders that participated during the meeting and prayed for the success of the SABER's project in Adamawa State.
