ADAMAWA STATE EXECUTIVE ORDER No. 2. OF 2023

CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA

EXECUTIVE ORDER ON THE ESTABLISHMENT OF INVESTMENT PROMOTION AND PUBLIC PRIVATE PARTNERSHIPS UNIT

WHEREAS, It is the policy of Adamawa State Government to attract foreign and domestic direct investment into the State

NOW THEREFORE I 'RT. HON. AHMADU UMAR FINTIRI, EXECUTIVE GOVERNOR OF ADAMAWA STATE, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY THE 1999 CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA AND THE LAWS OF ADAMAWA STATE, HEREBY ORDER AS FOLLOWS:

- I. It is hereby established a unit in the office of the Secretary to the State Government to be known as the Investment Promotion and Public Private Partnership Coordinating Unit (hereinafter referred to as "The Unit"). The Unit, inter alia, shall develop, promote, facilitate and coordinate investments in the state through Greenfield, Public-Private Partnership, Privatization, Commercialization, Concessions of State-owned assets.
- II. Advise and assist the Government on the implementation of all projects and programmes in the investment promotion roadmap of the State
- III. Develop appropriate institutional and regulatory frameworks for investment promotion, Public-Private Partnership, Privatization, Commercialization, Concessions in the State
- IV. Articulate clear private sector growth strategies for providing needed support and appropriate incentives to grow the local and private sector and enlarge the economic base of the State;

- V. Advise and assist the Government in developing and maintaining a comprehensive and reliable database on investment opportunities for effective planning especially in areas where the State has demonstrable comparative and competitive advantages
- VI. Conclude arrangements with any person or authority for the effective implementation of any programme or project and to enter into such other contracts as it may deem necessary to facilitate its functions under this Executive Order
- VII. Do such other things as are necessary and incidental, supplemental or conducive to its function under this Order.

THIS EXECUTIVE ORDER SHALL TAKE EFFECT FROM THE DATE OF ISSUANCE OF THIS ORDER.
